WARNING: BY SIGNING THIS AGREEMENT, YOU GIVE UP ANY RIGHT YOU MAY HAVE TO RECOVER COMPENSATION THROUGH THE COURTS OR OTHERWISE, FOR ANY PERSONAL INJURIES, DAMAGE TO YOUR PROPERTY, OR FOR YOUR DEATH, ARISING OUT OF YOUR USING THE CLIMBING WALL AND/OR OTHER FACILITIES OF VALLEY BIBLE CHURCH AND/OR OUT OF YOUR OBSERVING OR PARTICIPATING IN THE ACTIVITIES SPONSORED BY VALLEY BIBLE CHURCH, EVEN IF YOUR INJURIES OR DAMAGES ARE CAUSED BY NEGLIGENCE OF THE PERSON(S) BEING RELEASED. YOU WILL BE ASSUMING RESPONSIBILITY FOR ALL RISKS, WHETHER FORESEEABLE OR NOT, CONNECTED WITH YOUR PRESENCE AT THE FACILITIES OR ACTIVITIES OF VALLEY BIBLE CHURCH. BE SURE THAT YOU HAVE READ AND UNDERSTOOD THIS AGREEMENT BEFORE SIGNING IT.

IN CONSIDERATION FOR MY BEING ALLOWED TO OBSERVE AND/OR PARTICIPATE IN THE ACTIVITIES OF THE VALLEY BIBLE CHURCH CLIMBING WALL, I HEREBY RELEASE AND DISCHARGE VALLEY BIBLE CHURCH AND ANY OTHER OWNER, MANAGER, OPERATOR, MEMBER, EMPLOYEE, VOLUNTEER OR AGENT OF THE VALLEY BIBLE CHURCH CLIMBING WALL, INCLUDING SOLID ROCK WALL SYSTEMS, FROM ANY AND ALL CLAIMS, LIABILITIES ARISING OUT OF ANY NEGLIGENCE WHATSOEVER WHICH CAUSES INJURY TO ME OR TO MY PROPERTY, OR WHICH CAUSES MY DEATH, WHILE I AM USING THE FACILITIES AND/OR CLIMBING WALL OF VALLEY BIBLE CHURCH.

I ALSO RELEASE AND DISCHARGE THE LANDLORD OF VALLEY BIBLE CHURCH AND ANY DESIGNERS, MANUFACTURERS, INSTALLERS, OR DISTRIBUTORS OF THE FACILITIES OR EQUIPMENT OF THE VALLEY BIBLE CHURCH CLIMBING WALL FROM ANY AND ALL CLAIMS AND LIABILITIES ARISING OUT OF ANY NEGLIGENCE WHATSOEVER WHICH CAUSES INJURY TO ME OR TO MY PROPERTY OR WHICH CAUSES MY DEATH, WHILE I AM OBSERVING OR PARTICIPATING IN ACTIVITIES SPONSORED BY VALLEY BIBLE CHURCH, OR WHILE I AM USING THE FACILITIES OF VALLEY BIBLE CHURCH, INCLUDING THE CLIMBING WALL.

I ALSO PROMISE NOT TO SUE ANY OF THE RELEASED PERSONS FOR ANY CLAIMS ARISING OUT OF INJURIES CAUSED TO ME OR MY PROPERTY BY THEIR INDIVIDUAL OR COLLECTIVE NEGLIGENCE.
